# Public Health Reimagined

A Blueprint for Building a Modern, Responsive, and Cost-Effective SystemEARTH of Public Health and Prevention for Maine



**Goal 1:** Promote a vision for health and productivity that attracts new businesses, strengthens Maine's workforce, and gives kids a hopeful future through bold leadership, innovative promotion, and public education.

### **Recommendations** to raise the profile and relevance of public health among Maine people and government

- A. Actively promote a simple, modern, and relevant understanding of public health and prevention
- B. Establish and define the leadership roles and responsibilities of the State Public Health Officer and ensure the position is funded and filled
- C. Engage district and community leaders in identifying opportunities and strategies to consistently raise the profile and relevance of public health
- D. Build a functioning system of Local Health Officers that is integrated with municipal governments, local health care providers, and emergency management systems

**Goal 2:** Work smarter and connect the dots by improving the skills, expertise, and integration of public health, emergency management, community hospitals, and public safety at every level of jurisdiction.

#### **Recommendations** to improve the focus, skills, and inter-connectedness of public health among state agencies

- E. Affirm foundational public health services that must be performed by Maine's state health agency
- F. Provide tools and resources to ensure the impacts on health and childhood trauma are considered in all policies and strategies across all departments of state government
- G. Establish policies and practices that require and support a strong public health workforce

**Recommendations** to connect and integrate public health planning and advisory networks more firmly among all levels of government and government functions

- H. Establish a minimum number of Public Health Communities within each of Maine's 9 Public Health Districts in which community partnerships can be supported and local public health protections and services can be delivered
- I. Support community and district-level public health partnerships in establishing formal and informal linkages with other planning, program, and service-delivery entities to improve coordination, collaboration, efficiency, and effectiveness
- J. Require reciprocal representation among all levels of Maine's public health planning and advisory system

#### Goal 3: Support local solutions by rebuilding and revitalizing Maine's community health

infrastructure and public-private partnerships.

#### **Recommendations** to strengthen Maine's community health infrastructure

- K. Identify and fund at least one competent and qualified community health coalition in each of Maine's Public Health Communities
- L. Establish and fund basic and essential public health services and staffing, including public health nurses, for all Public Health Districts and Public Health Communities
- M. Define non-clinical community health workers, paraprofessionals, and lay health worker functions that support public health services and staffing, phasing in funding for priority regions

## **Goal 4:** Create fair and equal opportunities for success by addressing geographic and

demographic differences in Mainers' access to high quality health information and preventive care.

**Recommendations** to solidify Maine's commitment to ensuring health equity and addressing health disparities

- N. Assure and fund the Tribal Health District
- O. Revise and fund an Office of Health Equity that is advisory to and reports directly to the Commissioner of DHHS and is accessible to every administrative department

**Goal 5:** Take the politics out of prevention by retooling how we set public health priorities, maximize the use of federal funds, and allocate Maine's tobacco settlement.

Recommendations to improve resource attainment and evidence-based priority-setting

- P. Establish a quasi-governmental entity to receive and allocate Maine's tobacco settlement funds in such a manner as to fully fund tobacco prevention and control efforts and to support other State Health Improvement Plan priorities
- Q. Designate the Maine Public Health Institute as an agent of Maine DHHS for the purpose of applying for federal funds to support public health research and programming
